



## Information Letter of the X International Forum outcomes “The Innovation Development through the Market of Intellectual Property”

**On April 20, 2018** within the framework of World Intellectual Property Days under aegis of the United Nations (on the basis of the Moscow Technological University (MIREA)) there was held X Anniversary International Forum “The Innovation Development through the Market of Intellectual Property”, which participants represented WIPO, SCO, CIS, EEC EAEU, Common State, public authorities, science and education institutions, business and public organizations, mass media of all EAEU countries, as well as the Republic of Moldova and the Republic of Bulgaria, including in videoconference mode at regional sites in the Russian regions (on the basis of the Siberian Federal University - SFU, Krasnoyarsk, Ural State Economic University - USUE, Ekaterinburg). On-line mode - video broadcast of the Forum on the websites of its organizers - allowed to participate almost unlimited number of interested participants, both in Russia and abroad.

*The Forum was organized* by the CIS Executive Committee and EEC EAEU, the Russian Academy of Sciences, the Intellectual Property Corporation RSRIIP, the International Association of Intellectual Property Institutions (IAIPI) and MIREA. All these years, the Republican Scientific Research Institute of Intellectual Property (RSRIIP) – the only scientific non-profit organization in EAEU and CIS that specializes on problems of intellectual property and provides services in this field at the level of international ISO standards, has been acting as *the Forum Directorate and Sponsor*. The key *media partners of the Forum* included the interstate TV and radio company MTRK “MIR”, the publishing group “Jurist”, journals “Intellectual Property Law”, “Russian Competition Law and Economics” and “Information Law”.

The organizers, participants and guests of X International Forum “The Innovation Development through the Market of Intellectual Property” were addressed the greetings from: the Chairman of the Government of the Russian Federation **D.A. Medvedev**, Director General of WIPO **Francis Gurry**, the Chairman of the Executive Committee - the Executive Secretary of CIS **S.N. Lebedev**, Deputy Secretary-General of the Shanghai Cooperation Organisation **Wang Kaiwen**, Member of the Board (Minister) for Economic and Financial Policy of the Eurasian Economic Union **T.M. Zhaksylykov**, the State Secretary of the Common State **G.A. Rapota**, the Director of the National Center for Legislation and Legal Studies of the Republic of Belarus **V.D. Ipatov**, the Chairman of the Fund “For sustainable development of Bulgaria” **Stanka Shopova**.

The Chairman of the Government of the Russian Federation **Dmitry Medvedev**, while greeting participants of the Forum, noted that “intellectual property is the unique economic resource, without which innovative development is impossible. Scientific and technical creativity, new ideas, inventions, discoveries are the main wealth of any country. That is why your traditional meetings dedicated to the protection of intellectual property arouse much interest not only in the professional community, but also among representatives of different states. After all, the Forum is the platform where topical issues are discussed, where it is possible to exchange experience and find effective solutions. The main topics of the meeting are the Eurasian market of intellectual property and competitiveness in the digital economy, pricing, taxation and accounting in innovative companies, protection from unfair competition, combating counterfeit.” At the same time, he expressed confidence that “by joint efforts we will certainly achieve success in this area. I expect that the discussion at the Forum will turn out to be constructive and useful, and will serve to further strengthen interregional and international innovative cooperation. In addition, the proposals you would formulate will find their practical application.”

At the beginning of the Forum, his permanent co-chairman **S.V. Stepashin**, who opened the first forum in 2008, noted that the anniversary of the Forum had coincided with the anniversary of the complete codification of Russian legislation on intellectual property, in which Russia became the first country in the Post-Soviet space, as well as five years ago the first specialized court on intellectual rights was created. Over these years, the Forum has become a universally recognized annual event in the CIS and the Eurasian Economic Union (EAEU). The implementation of the digital agenda announced in Russia and other EAEU and CIS countries ensures successful integration and involves the development of common approaches, mechanisms and rules for the formation of the Eurasian intellectual property

market. And this confirms the correctness of the path proposed during this Forum 10 years ago.” The uniqueness of the Forum - according to S.V. Stepashin, is not only in the focus on the Eurasian problems in the transition to digital economy, and we hope that our recommendations will be heard and used by the representatives of the governing bodies of the Eurasian Economic Union. Its peculiarity is also in practical approaches to finding mechanisms for solving these problems and discussing draft documents that authorities and business community have been waiting for a long time.

In his greetings the rector of the Moscow Technological University (MIREA) – the biggest and oldest university in Russia specialized in the training of the personnel in the sphere of electronics and automatics, Doctor of Technical Sciences, Professor **S.A. Koudzh**, outlined the special importance of the Forum held for solving issues, first of all, connected with formation and development of science and practice in the field of digital economy and intellectual property and training of personnel in this sphere.

Within the framework of the Forum two plenary and five special sessional meetings took place:

**“Eurasian intellectual property market and competitiveness in digital economy”** (on national – regional – industry – corporate level) (*moderators: V.N. Lopatin*, the Head of the Corporation of Intellectual Property RSRIIP, the Chairman of Interstate (ITC 550) and National Technical Committee on standardization “Intellectual Property”, Doctor of Laws, Professor); **A.Zh. Sultangazin**, the President of the Joint-stock company “Science Fund” of Republic of Kazakhstan, Doctor of Economics, Professor), within which the following speakers presented: **V.D. Ipatov**, the Director of the National Center of Legislation and Legal Research of Republic of Belarus, **S.S. Losev**, Senior Research Scientist of the Department of Research in the field of civil, environmental and social law of the Institute of Legal Research of the abovementioned Center, as well as **S.B. Aliev**, Assistant to the Minister (member of the Board) on economics and financial policy of the Eurasian Economic Commission of the EAEU, Senior Research Scientist of the IPCO RAS, Doctor of Technical Sciences, Professor;

**“Pricing, accounting, risk insurance and intellectual property management in credit organization”** (*moderators: V.V. Gruzdov*, Director of the Research and Production Enterprise “Pulsar” of the state corporation “Rostekh”, Member of the Council of the Military-Industrial Commission on Pricing and Financial and Credit Policy in the execution of the State Defense Order, Chairman of the Committee on Economics and Finance of the Union of Russian Aviation Manufacturers; Head of the Department of Economics of Intellectual Property of the Financial University under the Government of the Russian Federation, Head of the Department “Economics of Intellectual Property in the Radio Industry” MTU (MIREA), Candidate of Economic Sciences, Professor; **M.V. Klyashnya**, Deputy Head of the Department of Insurance of Liability and Financial Risks of Insurance House “VSK”);

**“Protection of intellectual property from unfair competition”** (*moderator: S.V. Maksimov*, Assistant to the Head of the Federal Antimonopoly Service of the Russian Federation, Doctor of Laws, Professor), during which **V.N. Sinelnikova** – Chief Research Scientist of RSRIIP, Doctor of Laws, Professor - presented the draft of GOST R “Intellectual Property. Antimonopoly regulation and protection against unfair competition” prepared by the RSRIIP’s authors team;

**“Customs protection of intellectual property and combatting counterfeit in the Eurasian Economic Union”** (*moderators: A.A. Aslakhonov*, the President of the International association “Anti-counterfeit”, Doctor of Laws, Professor; **V.I. Kozlov**, First Deputy Head of the Office of Customs Investigation and Inquiry of the Federal Customs Service of the Russian Federation, which presented for public discussion the draft of GOST “Intellectual Property. Customs protection”);

**“Personnel for the market of intellectual property”** (*moderators: F.I. Shamkhalov*, Academic Secretary of the Research and Production Enterprise “Pulsar” of the state corporation “Rostekh”, Director of the scientific and technological center of solid state electronics MIREA, Doctor of Economics, Professor; **G.M. Golobokova**, Acting Head of the Specialized Department of RSRIIP “Management of Intellectual Property” of the Russian Economic University named after G.V. Plekhanov, Doctor of Economics, Professor).

**More than 60 reports** on the problematic and perspective questions of innovative development and digital economy and approaches to its solutions on national and international levels that occur while forming the Eurasian intellectual property market in countries of Eurasian Economic Union and CIS were announced and presented during these forums with due account for the best international and foreign experience.

On the plenary session **“Problems and perspectives of the formation of the Eurasian intellectual property market in digital economy”** **V.N. Lopatin**, the Head of the Corporation of

Intellectual Property RSRIIP, the Chairman of Interstate Technical Committee on standardization “Intellectual Property” (ITC 550), presented the key report “Problems and priorities of the formation of the Eurasian intellectual property market in 2017 and in the long run till 2025 as a condition of competitiveness of the CIS and Eurasian Economic Union” as presentation of the annual report “On the status of legal protection and use of intellectual property in the Eurasian Economic Union and CIS in 2017 and development priorities until 2025”.

On the plenary session the following representatives from international and interstate entities, state authorities, state corporations, scientific, education and public organizations of the Eurasian Economic Union presented their opinions on the topics of the Forum (both in the spoken and written word):

Aldoshin**, Chairman of the Board of Directors of the Joint Institute of Chemical Physics of the Russian Academy of Sciences, Chairman of the Scientific Council of RSRIIP, Academician of the Russian Academy of Sciences (on the opportunities of the academic science and problems of its assessment and use in transition to the digital economy);

**A.Zh. Sultangazin**, the President of the Joint-stock company “Science Fund” of the Ministry of defense of Republic of Kazakhstan, Doctor of Economics, Professor (on problems of Eurasian intellectual property market formation and experience in Republic of Kazakhstan);

Omorov**, Counsellor to the Director General of the free economic zone “Bishkek”, Doctor of Technical Sciences, Professor, Corresponding Member of the National Academy of Sciences of the Kyrgyz Republic (on intellectual property and indicators of innovative index of Kyrgyz Republic and other CIS countries);

**A.A. Aslakhonov**, the President of the International association “Anticounterfeit”, Doctor of Laws, Professor (on the current problems and practice of counterfeit combating in the Eurasian Economic Union);

**A.A. Piskunov**, Senior Research Scientist of the Institute of Social and Political Sciences of the Russian Academy of Science, Candidate of Economics Sciences (models and metrics of spatial development of Eurasian Economic Union);

**E.V. Ugrinovich**, Director General of the intergovernmental association “International center of the scientific and technical information (ICSTI)” (on the system of the scientific and technical information as the most important element of the infrastructure of the digital economy);

**E.L. Pisarevsky**, First Deputy Head of the Social Insurance Fund of the Russian Federation, Doctor of Laws, Professor (experience and problems of the application of the digital technologies when rendering public services in the social sphere);

**A.A. Ischenko**, Chairman of the Central Council of All-Russian Society of Inventors and Innovators, Candidate of Economic Sciences

The results of the discussion of the current problems on the sessions regarding the topics of the Forum were presented by its moderators on the final plenary session during which the participants expressed the public recognition to the heads of international organizations and state authorities of Russia, the countries of the Eurasian Economic Union and the CIS for their greetings and attention to the work of the Forum and adopted **the final document - the recommendations** of the Forum, tentatively approved during the enlarged meeting of the Observatory and Academic Council of RSRIIP with the participation of the members of the MIREA Scientific Council.

The Program Committee, Organizational Committee and Directorate of the Forum were entrusted to finalize the document on the outcome of the discussion and to send information on the outcome of the Forum and its recommendations to the WIPO and WTO, UNESCO, the SCO, the CIS, the Eurasian Commission of the EAEU and the Common State, national parliaments and governments of the member states of the EAEU.

Following a public discussion, the participants of the Forum supported the drafts of GOST R “Intellectual property. Antimonopoly regulation and protection from unfair competition” and GOST “Intellectual property. Customs protection”, prepared at RSRIIP in accordance with the programs of interstate and national standardization for 2018.
