



Conditions for personal data processing of the Forum participant

Hereby I (hereinafter referred to as the “**Personal Data Subject**”), acting on my own will and in my own interests, with the aim of gaining access to the enhanced functionality of the web-site <http://www.rniis.ru/> (hereinafter referred to as the “**Web-site**”), being familiar with the provisions of the Federal Law No. 152-FZ as of July 27, 2006 “On Personal Data”, the Personal Data Processing Policy, and in accordance with the terms of the latter, I give my consent to the Directorate of the Forum (Operator) for processing (action (operation) or a set of actions (operations) performed with using automation tools or without the use of such tools, including copying, storing, clarification (updating, changing), retrieving, using, accessing, blocking, deleting, destruction) of my personal data specified during registration on the Web-site, namely:

- full name; position, academic degree (if any);
- full and abbreviated name of the organization (which interests I am authorized to represent), as well as the profile of the organization;
- e-mail address; contact phone number.

I have read and agree with the fact that:

(a) Consent for processing of personal data is valid from the moment of acceptance of the terms of this Consent by placing a mark (“tick”) in a cell “I have read and agree to the terms of personal data processing”;

(b) Consent for processing of personal data can be revoked on the basis of my application in any form sent to the Directorate of the Forum (Operator) by e-mail forum@rniis.ru. The Directorate of the Forum (Operator) no later than 10 (ten) working days from the date of receipt of an application on withdrawal of the Consent for processing of personal data stops processing and deletes my personal data;

(c) in case of withdrawal of the Consent for processing of personal data, the Directorate of the Forum (Operator) is entitled to continue processing of personal data without my consent in case there are grounds provided for by part 2 of Art. 9 of the Federal Law No. 152-FZ as of July 27, 2006 “On Personal Data”.

By accepting the terms of this Consent, I confirm that:

- Consent for processing of personal data is specific, informed and conscious;
- I am not under the influence of drugs affecting the processes of memory, perception, attention, ability to understand the meaning of decisions and actions, as well as in the state of alcoholic, narcotic, toxicological, medicinal or other intoxication;
- I am not incapable or partially capable.

The validity of the Consent is 5 (five) years from the date of registration of the Personal Data Subject on the Web-site. The term is extended automatically if the Subject has not notified the Forum Directorate (Operator) of its (Consent) withdrawal until the expiration date of the Consent.
